**PUEBLO SIN FRONTERAS**

*“The most successful politician is he who says what the people are thinking most often in the loudest voice.” Theodore Roosevelt, 26th President of U.S.*

The main-stream-media (MSM) calls them “caravans.” A better description is “mobs.” Thousands of migrants from El Salvador, Guatemala and Honduras are headed to the United States under the guise of seeking asylum. Organizing the invasion is Pubeblos Sin Fronteras (people without borders.) Their dream is “to build solidarity bridges among peoples and turndown border walls imposed by greed.”

Organizing Honduras migrants is Bartolo Fuentes, a former politician and host of a radio show on migration: “Without Borders.” The Honduran government views Mr.Fuentes as a human trafficker taking advantage of people for political purposes. In an interview to the Daily Beast, Mr. Fuentes said the migrant numbers grew when it was falsely reported (fake news) that he would pay for the migrants food and transportation. Now, more mobs are forming in Central America to challenge U.S. sovereignty.

KTAR News in Phoenix interviewed Immigration & Customs Enforcement (ICE) Field Director, Henry Lucero. He said, “On the news in Guatemala they are saying that you can get a work permit if you’re in a family, if you’re coming with your child, and that you’re going to be released.” Make a bogus asylum claim and U.S. “catch and release” program insures your entry.

We all want Central Americans to live in safety and enjoy employment opportunities. But as a sovereign nation we must welcome immigrants legally. According to the Gallup World Poll, 29 percent of people who want to migrate from Latin America and the Caribbean want to make the United States their permanent homes. Folks, that’s 37 million people who want to come here! That’s another California!

Strong young men wave Honduran and Guatemalan flags as they march to the U.S. border. Do you believe they want to assimilate? Several thousand migrants turned down Mexico’s offer of benefits if they applied for refugee status and stayed in the country’s two southernmost states.

The MSM criticizes President Trump for tweeting: “criminals and unknown Middle Easterners are mixed in.” If only MSM would investigate. In June 2016, Obama’s head of the Department of Homeland Security (DHS) sent a memo to law enforcement agencies citing, “Cross-Border Movement of Special Interest Aliens. (SIA)” SIA’s are individuals from 35 countries that “have shown a tendency to promote, produce, or protect terrorist organizations,” per the DHS.

Guatemalan President Jimmy Morales publicly stated that he deported 100 Middle Easterners in his country, some with suspected ties to terror. His government warned of Middle Easterners traveling through the smuggling routes headed north.

Michael Braun, former chief of operations for the U.S. Drug Enforcement Administration believes President Trump is right to be concerned. Mr. Braun offered this statement:

“The President is justifiably concerned about Middle Eastern terrorist organizations exploiting our borders...Hezbollah’s growing involvement in the global cocaine trade over the past decade has resulted in the formation of alliances with Colombian and Mexican drug tracking cartels, the most sophisticated transnational organized crime syndicates law enforcement has ever faced.”

Mexico’s National Migration Institute issued a warning that groups were building molotov cocktails with the intent of using them against Mexican border police. Two migrants were arrested for shooting at Mexican border police. Geronimo Gutierrez, the Mexican ambassador to the U.S., described some of the migrants as “very violent” in an NPR interview.

What should President Trump do? He should go on national TV and explain to Americans the seriousness of protecting our sovereignty. He should implement Section 212(f) of the Immigration and Nationality Act (INA): *“Whenever the President finds that the entry of any aliens or of any class of aliens into the United States would be detrimental to the interests of the United States, he may by proclamation, and for such period as he shall deem necessary, suspend the entry of all aliens or any class of aliens as immigrants or nonimmigrants, or impose on the entry of aliens any restrictions he may deem to be appropriate.”*

In addition to INA 212(f), there is another section — INA 215(a)(1) —it states:

*Unless otherwise ordered by the President, it shall be unlawful—  
(1) for any alien to depart from or enter or attempt to depart from or enter the United States except under such reasonable rules, regulations, and orders, and subject to such limitations and exceptions as the President may prescribe;*

Trump must demand that all immigrants enter legally and apply for asylum at a U.S. consulate in Mexico and not on our borders. The federal government must do everything in its power to peacefully stop the mobs and send a clear message. Last, give elite progressives bullhorns. Let them tell the mobs that America was never great, that its racist and harbors xenophobia, nativism and capitalism. That Central America is a better place.
